The Fine Print

FEES INCLUDE

- The use of the facility (sanctuary/chapel and dressing rooms) for both the rehearsal and the wedding ceremony,
- Fees for the pastor, the organist, audio services if in the Sanctuary, the wedding directors, and
- Arrangements for available clean up on the day of your wedding.
- A deposit of \$500 is required for all weddings.
- All fees are due 4 weeks prior to the wedding.

REHEARSALS

Rehearsals are scheduled the Friday evening before the wedding.

CANCELLATIONS

If your wedding is cancelled at least six weeks before the scheduled date, you will receive one half of your deposit as a refund. If the wedding is cancelled within six weeks of the scheduled date, your entire deposit is nonrefundable. A refund check will be issued the week following your wedding unless damage has been done to the facility.

ADDITIONAL FEES

MUSICIANS

Please note that there will be an additional \$30 per musician added to the ceremony. This is to compensate the organist for practice time with each guest musician.

DISCRETIONAL FEES

An additional fee (at the discretion of the Saint Mark Wedding Director) will be assessed if either the rehearsal or the ceremony begins more than half hour after the scheduled time or if the ceremony lasts 30 minutes longer than the reserved time.

The amount of the fee will be determined by the length of time and the hourly rate of the service provider whose time is extended (i.e.: security, musicians, etc.) beginning at \$50 per half-hour for each person involved.
